QUICK MOUNT PV, INC., ("Quick Mount PV") warrants to the original retail purchaser ("Owner") of Quick Mount PV's Classic Composition Mount, manufactured by Quick Mount PV ("Product") that the structural components of the Product will be free from substantial defects in material and workmanship and that Product finish will be free from visible peeling, cracking or chalking under normal atmospheric conditions ("Finish Warranty") while the Product is installed at its original installation site provided that the Product was installed in accordance with Quick Mount PV's written installation instructions.

Limited Warranty Period

This Limited Warranty covering the structural components of the Product is made for twenty (20) years and the Warranty covering the anodized finish is made for five (5) years, from the earlier of 1) the date the installation of the Product is completed, or 2) thirty (30) days after the purchase of the Product by the original Owner.

Limited Warranty Coverage

QUICK MOUNT PV will, at its sole option, either repair or replace any Product or components of the Product that fail to meet the performance standards set forth in this Limited Warranty on an exchange basis without charge. If QUICK MOUNT PV is unable to repair or replace a defective Product or component within a reasonable time, QUICK MOUNT PV will, at its sole and exclusive option, either replace the defective Product or component with a functionally equivalent Product or component without charge, or refund the original price paid for the defective Product or component. These are your sole and exclusive remedies under this Limited Warranty.

Limited Warranty Exclusions

QUICK MOUNT PV does not warrant that the Product will meet any specifications, needs, or requirements not expressly set forth in Quick Mount PV's technical documentation of the Classic Composition Mount. The Finish Warranty does not apply to any foreign residue deposited on the finish. All installations in corrosive atmospheric conditions are excluded. The Finish Warranty is void if, when cleaning or maintaining the Product, the practices specified by AAMA 609 & 610-02 – "Cleaning and Maintenance for Architecturally Finished Aluminum" (www. aamanet.org) – are not followed by Owner.

This Limited Warranty does not cover damage to the Product that occurs during shipment, storage, or installation. This Limited Warranty shall be void if the Product is not installed in accordance with Quick Mount PV's written installation instructions, if the Product is installed in an environment for which they were not designed, or if the Product has been modified, repaired, or reworked in any manner not previously authorized by Quick Mount PV in writing.

This Limited Warranty covers only the Product and components provided by Quick Mount PV. Quick Mount PV makes no warranties or representations regarding any items or material provided by third parties.

FURTHER EXCLUSIONS
